

Official Rules — Seattle Home Show's Facebook Giveaway

NO PURCHASE NECESSARY.

1. This Game is played from 10:00 a.m., PT, February 23, 2019 ("Game-Start") to 11:59 p.m., PT, March 3, 2019 ("Game-End").

HOW TO ENTER IN THE CONTEST.

2. Eligibility: You may enter if you are a legal resident of the state of Washington and aged 21 or older at the time of entry. One entry per person. Employees, officers, directors, agents, representatives and their immediate families (parents, children, siblings, spouse and each of their respective spouses, regardless of where they live) or members of household of the Seattle Home Show, their parent companies, subsidiaries, advertising, design, web design, web hosting and publicity agencies and anyone connected with the production and distribution of this Contest are not eligible to enter or be awarded a prize.
